Washington Update

1. Congress has settled in and it is time to contact your elected representatives to urge them to introduce legislation supporting human rights, democracy and economic development in Ethiopia. Ethiopian-Americans should especially contact Rep. Donald Payne, tel. (202) 225-3436, and Rep. Chris Smith, tel. 202-225-3765. In the Senate, contact Sen. Russell Feingold, (202) 224-5323. Callers should mention their support for legislation that passed the House last year. Also, discuss an excellent report issued last month by the State Department on human rights in Ethiopia.

The State Department's 2008 report on human rights in Ethiopia stated: "Human rights abuses reported during the year included limitations on citizens' right to change their government in local and by-elections; unlawful killings, torture, beating, abuse, and mistreatment of detainees and opposition supporters by security forces, usually with impunity; poor prison conditions; arbitrary arrest and detention, particularly of suspected sympathizers or members of opposition or insurgent groups; police and judicial corruption; detention without charge and lengthy pretrial detention; infringement on citizens' privacy rights including illegal searches; use of excessive force by security services in an internal conflict and counterinsurgency operations; restrictions on freedom of the press; arrest, detention, and harassment of journalists; restrictions on freedom of assembly and association; violence and societal discrimination against women and abuse of children; female genital mutilation (FGM); exploitation of children for economic and sexual purposes; trafficking in persons; societal discrimination against persons with disabilities and religious and ethnic minorities; and government interference in union activities, including harassment of union leaders."
